

WHAT WOULD MY HEALTH ADVOCATES' ATTORNEY DO TO REPRESENT ME AND HELP ME WIN MY CASE?

Every disability case is different and your attorney's role depends on the particular facts of your case. In most cases, your attorney and the staff at Health Advocates will:

- Assist you with completing and submitting the application and all SSA forms
- Contact your Local SSA District and/or OHO office to confirm that everything was received and is being processed timely and expeditiously
- Request and submit to SSA all medical records and other evidence
- Analyze and process your case under SSA regulations
- Contact and send your doctor Physical/Mental Residual Capacity Assessment forms for completion to support your claim
- Obtain and review all documents from your SSA file, including information submitted on prior applications and review SSA actions
- Review actions taken by the SSA to confirm if regulations were followed and that the decisions made relating to your case were correct
- Request that a prior application for benefits be reopened if applicable
- Submit "Good Cause" letter to SSA when a time limit or deadline was missed if we can establish good cause for late filing
- Submit "Dire Needs" letter and/or "On The Record" request to SSA to try and expedite an early decision on your case
- Send Field Representatives to the office of your medical provider(s) in order to copy/scan your medical records and submit them to SSA
- Advise you how to best prepare yourself to testify at your hearing
- Protect your right to a fair hearing by objecting to improper evidence and procedures
- Cross-examine adverse witnesses at your hearing
- Present an opening and closing statement
- Submit a written summary of the evidence and argument to the Administrative Law Judge
- Make sure the SSA correctly calculates your cash benefits, if you win, AND timely activates your Medi-Cal/Medicare benefits

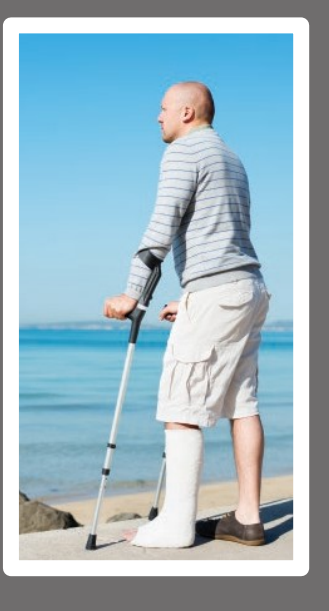

WHAT ARE SSI AND SSDI DISABILITY BENEFITS?

SSI and SSDI are disability benefit programs run by Social Security Administration (SSA). Both programs pay **monthly cash benefits** to people with disabilities that will last twelve (12) or more months and who cannot maintain substantial and gainful employment. To get SSI and SSDI benefits, you must be **disabled under SSA's rules**.

WHAT IS THE MAIN DIFFERENCE BETWEEN SSI AND SSDI?

SSI is for people with disabilities who have low income and assets less than \$2,000 or \$3,000, if married. You can receive SSI if you have never worked. If approved for SSI, you will also receive Medi-Cal benefits.



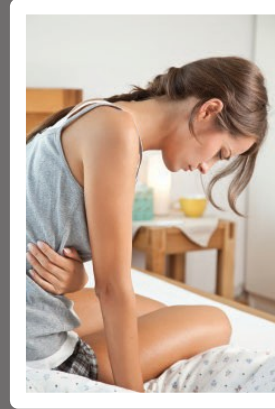
WHAT CAN I DO TO HELP?

It is important for you to develop your case as accurately and completely as possible. These are some of the areas that SSA will take into account as you are reviewed for disability benefits. Being as thorough as possible on the areas below is critical for strengthening your case:

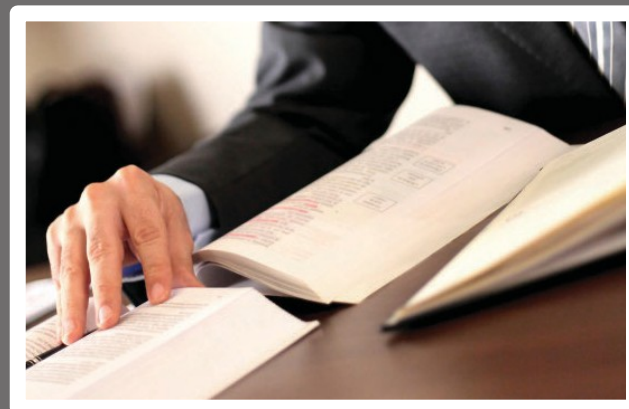
- Medical Condition(s)
- Medical History
- Medical Records
- Physical Abilities
- Mental Abilities
- Education and Training
- Past Relevant Work Experience
- Daily Activities

DO I NEED AN ATTORNEY?

Research shows that a large majority of SSI/SSDI cases are denied upon application and require additional appeals and/or a hearing. Although the informality of the hearing makes it possible for some claimants to represent themselves, statistics have shown that people represented by attorneys have been successful more often than people without attorney representation. Whether you hire an attorney is entirely up to you, but you are significantly increasing your odds of being approved for benefits if you hire the right attorney to assist you.



SSDI is for people with disabilities who have a recent work history. Usually, you need to have worked 5 out of the last 10 years to receive SSDI. The amount of SSDI you receive if you win your case, depends on your past earnings. SSDI has no income or asset limits. If approved for SSDI, you will also receive Medicare benefits after a 24-month waiting period.
