## **FAIR HOUSING CERTIFICATION TRAINING FOR INDUSTRY PROFESSIONALS**

The Housing Rights Center conducts Fair Housing Certification Trainings designed to inform and educate housing providers, managers, and industry professionals about the fair housing laws and illegal housing practices.

The Training Seminars cover the following topics:

- Federal, state and local fair housing laws;
- Familial status protections;
- Disability protections;
- Sexual harassment in housing;
- Fair housing laws and advertising, and;
- Hate crimes in housing.



The seminar includes self-evaluated tests, discussions of fair housing scenarios, a question and answer session, and a certificate of completion.
